Update on Funding (Lisa Pugliese)

The Lake County Community Fund offers a managed fund service that may meet our needs for accepting charitable donations (although a \$10,000 deposit is required to open the fund). This is a solution that can also work for other land banks, and may ultimately be a less expensive and less cumbersome solution than starting a new foundation. They are willing to have someone available by phone for 15-30 minutes during our May 15 meeting if you like.

Also spoke with Casandra Slade, Wintrust's CRA Officer. They provide end-user financing through the Cook County Land Bank, and would consider doing so for LC. Providing funding for acquisitions or a line of credit would be tricky at this point because we have nothing with which to secure such a loan. In theory, they will consider a donation to operations but it must go through a 501c3. Realistically, she said the lack of other seed money for operations is a concern.

Property List

Round Lake Beach: I've researched our standalone vacant businesses (i.e., not part of a shopping center)—we don't have many—and did not find one with a tax delinquency or lien that the land bank could potentially scoop up and turn quickly. We do have two potentially interesting opportunities, but they are likely too complicated at this stage. These are decent-sized parcels of land (one owned by the RLA Park District, the other by the Farm Bureau) that are prime for commercial development. Both would require the land bank to broker a deal among all of the parties and deal with a lot of politics; these would not have a quick turnaround.

Zion: Property owner is interested in donating property to the land bank. The address is 2101 Galilee Avenue in Zion. The lot size is about .17 acres. An aerial image of the parcel is attached.
